Please note: A Security Worker Under Supervision Licence expires 90 days after it is issued and cannot be renewed. Renewal applications can be submitted 90 days prior to expiry, with best results when renewal applications are submitted 60-90 days prior to licence expiry Under British Columbia's Security Services Act , businesses and individuals offering security services must hold a valid security licence issued by the Registrar of Security Services.

Renew Your Security Guard Licence – Quebec Your agent licence will be given to you for a period of 5 years. You must, therefore, submit a request to renew your licence every 5 years.. This request must be sent to us at least 45 days before the expiry date of your licence.

## **Renew your security guard licence**

You are required to produce a letter of no conflict from your superior officer Section 2.5.4 of the Security Licensing Process and Licence Conditions Policies for details on what must be in the letter). NOTE: A member of a police force as defined in the British Columbia Police Act may NOT hold a security worker licence.

A security guard as defined in Article 7A of the General Business Law [§89-f (6)] is a person (other than an active police officer) employed in NYS to principally perform one or more of the following duties, and the person is not performing the functions of a private investigator as defined in Section 71 of Article 7 of

the General Business Law:

## **NYS Division of Licensing Services**

The Private Investigators and Security Guards Act requires that all individuals conducting private investigation and/or security guard duties are licensed. Under The Private Investigators and Security Guards Act, individuals conducting loss prevention duties require a security guard licence, but must request a uniform exemption.

## **Private Investigators and Security Guards Program**

If your licence or registration expires between March 16 and June 16, 2020, it will be automatically extended for 90 days. Before the extended expiration date of 90 days, you will need to submit a renewal application for the licence or registration, or it will expire. All licence renewals are valid for two years.

### **Renew or replace a licence | Ministry of the Solicitor General**

A: All persons wishing to work as a security guard in British Columbia, must successfully complete their BST certification. Upon successful completion of your BST, you must then apply for your Security Worker license through the Ministry of Public Safety and Solicitor General, Security Programs Division, in order to be eligible to work.

To renew your licence: Book an appointment to renew your licence at an ICBC driver licensing office up to six months (180 days) before your licence expires. Renewing early won't shorten its validity. Bring two pieces of accepted ID

The security service licensing fee is \$100. Your licence is valid for 2 years. The renewal process is the same as the initial application. Security service workers can't hold a second licence as a locksmith or automotive lock bypass worker.
